

# RENTAL AGREEMENT FOR SWCD BRILLION SEEDER

The Brillion Sure Stand Seeder can be used to:

1. Establish grass waterways.
2. Establish field buffer strips.
3. Plant warm season grasses and/or forbes.
4. Plant wildlife food plots.

**RENTAL FEE: Annual Usage Fee of \$50.00 due at the time of rental. (this includes your first 1-4 acres). A \$12.00 per acre fee will be required upon return of the seeder for additional acres used. Acreage is always rounded up.**

## AGREEMENT CONDITIONS:

- The renter will pick up and return the drill as arranged with SWCD.
- The renter will vacuum excess seeds out of the drill so it is clean for next renter.
- Use of the drill must be conducted in a timely manner so as to give others a chance to rent the seeder. Delays due to weather will be approved by the SWCD board.

Normal wear and tear will be the responsibility of the Howard County SWCD. Damage due to negligence, abuse, or failure to follow instruction *WILL BE* the responsibility of the user. The District *WILL NOT* be responsible or be held liable for accidents when the drill is in your possession.

**IMPORTANT...Do NOT** allow anyone to take possession of the seeder until it has been cleared through the district office personnel. Damages resulting from such unauthorized use will be the responsibility of the previous renter.

Renter is responsible for inspecting condition of drill and recording required information in log book. Operating manual and log book are to be kept with the seeder at all times.

This agreement is to be signed and returned to the District *PRIOR* to use.

The District asks that if you are interested in renting the seeder that you complete this form and return it as soon as possible. This contract will be retained and valid for one calendar year to cover multiple rentals within the same year.
