RENTAL AGREEMENT FOR SWCD SEEDER

Uses for Seeder:

1. Establish grass waterways
2. Establish field buffer strips
3. Plant warm or cool season grasses and/or forbs
4. Plant wildlife food plots

RENTAL FEE: Annual Usage fee is \$50.00 (includes your first 1-4 acres) A \$12.00 per acre fee will be charged for anything over 4 acres. Acreage is rounded up.

RENTER AGREES (Please initial all boxes):

- Complete the rental agreement PRIOR to using the seeder. Contact the District 3-4 days ahead of usage for delivery date. SWCD personnel shall deliver and pick up the seeder.
- Normal wear & tear will be the responsibility of the district. Renter will perform an inspection of the seeder PRIOR to use and report any damage to the district office (765) 457-2114 x3.
- To calibrate the seeder to ensure accurate seeding rates and optimal seed output. To clean out excess seed from the boxes after using.
- To assume responsibility for and make any repairs due to my negligence during use the equipment, including tire replacement due to thorns or other punctures caused by on-site debris.
- To immediately contact the district when I have finished using the seeder and to report the actual number of acres planted upon completion.
- In consideration of being permitted to use the Brillion Sure Stand Seeder which I have rented from the Howard County Soil & Water Conservation District, I, FOR MYSELF AND MY HEIRS, REPRESENTATIVES AND ASSIGNS, HEREBY RELEASE, FOREVER DISCHARGE, INDEMNIFY AND HOLD HARMLESS the Howard County Soil & Water Conservation District, its board, officers, agents employees and representatives (the "Released Parties") and any person or entity acting on behalf of a Released Party from any and all responsibility or liability for injuries or damages (including attorney's fees and court costs) which the Released Parties may incur in connection with such claims or in connection with any judicial, quasi-judicial or administrative proceedings relating thereto resulting from or arising out of my use of the Brillion Sure Stand Seeder.
- I understand that the use of the Brillion Sure Stand Seeder which I have rented from the Howard County Soil & Water Conservation District involves a risk of injury and even death and that I am voluntarily using equipment and machinery with knowledge of the dangers involved. I acknowledge that Howard County Soil & Water Conservation District staff, even if present, will not be monitoring me or my activities while using the Brillion Sure Stand Seeder. I acknowledge that Howard County Soil & Water Conservation District staff are not qualified to render medical assistance in the event of a medical emergency. **I HEREBY EXPRESSLY AGREE TO ASSUME AND ACCEPT ANY AND ALL RISKS OR INJURY OR DEATH.**

Howard County Soil & Water Conservation District has the right to refuse any application and to determine the distance the seeder may travel.

This agreement will be retained and valid for one calendar year to cover multiple rentals within the same year.
